MEMORANDUM IN SUPPORT OF MOTION

The defendant is charged with attempting to entice a minor to engage in sexual activity by use of the internet pursuant to 18 U.S.C. 2422(b). The manner in which defendant is alleged to have acted to entice is by sending email messages and sexually explicit computer images over the internet to the alleged minor, in this case an undercover police operative posing as a minor. After defendant was arrested, the government seized the computer and disks found at his residence and began a detailed analysis of the contents of the computer. Among the materials derived by its analysis were: digital photographs, e-mail messages, and text from the computers obtained by using a text search in which key phrases or words were apparently used as the basis for search. A sample of such items is attached hereto as Exhibit "A".

Such evidence must be excluded from use at trial by the government for the reasons and grounds that are set forth herein.

The sexually explicit materials on his computer are clearly matters that many in the community would find highly objectionable and offensive. In United States v. Harvey, 991 F.2d 981 (2d Cir. 1993), the defendant was convicted of knowing receipt of a videotape transported in interstate commerce that depicted a minor engaging in sexually explicit conduct. The Second Circuit found that presentation of evidence concerning the contents of some of the adult X-rated videotapes seized from the defendant's residence was so prejudicial that it denied him the right to a fair trial. Id. at 995. Moreover, the court found that testimony by government witnesses concerning the title and contents of the videotapes as concerning gross acts and deviant sexual behavior as well as questioning the defendant about the contents, gave it "little difficulty in concluding that the likely effect of this evidence was to create disgust and antagonism toward [defendant], and resulted in overwhelming prejudice against him." Id. at 996. The Second Circuit concluded that not only were the materials introduced against the defendant "highly prejudicial," they also "posed a substantial risk of inflaming the jury," thereby denying defendant of a fair trial. Id.

In similar situations, the courts have found that sexually graphic and explicit materials that in the view of many jurors would constitute a "parade of filth" would "so clearly outweigh[ed] its probative value as to require exclusion under

Rule 403 of the Federal Rules of Evidence." Douglass v. Hustler Magazine, Inc., 769 F.2d 1128, 1142 (7th Cir. 1985), cert. denied, 475 U.S. 1094 (1986). There, the Seventh Circuit found that the trial court abused and "exceeded the limits" of its "broad discretion in balancing prejudice and probative value under Rule 403" when it allowed the presentation of a slide show of 128 worst pictures from the magazine, especially when the images were projected on a large screen to magnify the visual impact of the pictures. The court noted, at least with regard to protecting the press, the need to protect against "the fury of outraged juries." Id. Such should also be the case here, in a criminal case.

In Wood v. Alaska, 957 F.2d 1544, 1554 (9th Cir. 1992), the Ninth Circuit, finding that such evidence would confuse the issues and unduly prejudice the jury, affirmed a trial court's exclusion evidence that a victim of sexual assault posed for Penthouse, acted in pornographic movies, and had been paid to have sex in a room full of mirrors with people taking pictures. Id. at 1547. The Ninth Circuit stated that

if the jury considers these facts, it could feel hostility for her as an immoral woman, and it could base its decision on that hostility rather than on the actual facts of the case. The proffered evidence in this case is particularly prejudicial because it indicates not only the M.G. had extramarital sex, but also that she posed nude and had sex both for money and for the purpose of making pornography. Because many people consider prostitution and pornography to be particularly offensive, there is a

significant possibility that jurors would be influenced by their impression of M.G. as an immoral woman. . . . [emphasis added]

Id. at 1552. In this case, the defendant would suffer unfair and overwhelming prejudice from the introduction of items such as the matters disclosed by the government. Accordingly, it is requested that the court order in limine the exclusion from evidence at trial any and all computer-related images and/or text files depicting or describing explicit sexual conduct, pornography, or other similar matters.


